Giveaway Rules

THE CONTEST IS OPEN TO ALL CANADIAN RESIDENTS WHO ARE 19+ YEARS OLD. NO PURCHASE IS NECESSARY. Please read the following contest rules (the “Rules”) before participating in the Devour! Montréal Gourmet Weekend Getaway (the “Contest”). By entering the Contest, you agree to be bound by the Rules and declare that you meet all the eligibility requirements listed below.

1 ORGANIZER

The Contest is organized and run by Devour! The Food Film Fest (Slow Motion Food Film Fest Society) based at 1-360 Main Street, Wolfville, NS B4P 2R3, Canada (the “**Organizer**”).

PRIZE PROVIDERS

L'OFFICE DES CONGRÈS ET DU TOURISME DU GRAND MONTRÉAL INC. (TOURISME MONTRÉAL) is a prize provider in this Contest (the “**Prize Provider**”); its role in the Contest is limited to providing elements of the Prize (as defined below) to the Contest Organizer, which the Organizer will award to the confirmed winner. The Contest is in no way sponsored, organized, endorsed or administered by the Prize Provider.

AIR CANADA is a prize provider in this Contest (the “**Prize Provider**”); its role in the Contest is limited to providing elements of the Prize (as defined below) to the Contest Organizer, which the Organizer will award to the confirmed winner. The Contest is in no way sponsored, organized, endorsed or administered by the Prize Provider.

Providers of goods or services referred to herein constitute suppliers of the Organizer or Prize Provider and are not involved in any capacity whatsoever in the organization of this Contest.

2 ELIGIBILITY

2.1 The Contest is open to all Canadian residents who have reached the age of majority in their province or territory of residence at the time they enter the Contest.

2.2 Employees, representatives, and agents of the Organizer, Co-organizer and Prize Provider, (and anyone with whom the aforementioned people reside, whether related or not), and each of their respective parent organizations, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies and any other entity involved in the development, production, administration, or fulfillment of the Contest (collectively, the “**Contest Parties**”) may not participate in the contest.

2.3 The contest is subject to all applicable laws and is void where prohibited by law. Subject to the terms of the applicable laws, the Rules may be amended by the Organizer at any time and without notice, in particular to ensure compliance with the applicable laws or any instructions that may be issued from time to time by the competent authorities. A participant's eligibility is subject to compliance with the codes of ethics and standards of good conduct generally accepted on the internet. Failure to comply with the conditions of participation set out in the Rules will result in the disqualification of the participant and the nullification of their entry. Any participant who does not comply with the Rules or attempts to defraud or manipulate the operation of the Contest may be

disqualified, as may individuals living in the same household as the participant, and the Organizer may take any action deemed appropriate, including legal action.

3 CONTEST PERIOD The Contest will begin on **Sept. 4, 2025 at • (AST) and will end on Oct. 28, 2025 at 8 pm (AST)** (the “Contest Period”). **Draw will be made on Oct. 29th at 1pm (AST). Winner announced on Oct. 30, 2025 at 4 pm (AST).**

4 HOW TO PARTICIPATE To enter, simply follow the steps below during the Contest Period:

4.1 Visit Devour! The Food Film Fest (devourfest.com) contest page at •, and duly fill out and submit the contest entry form to receive one (1) entry in the Contest.

4.2 By submitting the entry form, the participant accepts the Contest Rules.

4.3 Participants must make sure they see the thank-you message before closing their web browser or navigating away from the page. The thank-you message confirms that their entry has been received and that the form has been properly submitted.

4.4 The time ascribed to the verification of the entry by the Organizer’s computer servers is the time that will be used to determine whether the entry was received during the Contest Period.

4.5 **NO PURCHASE NECESSARY.** An internet connection is required to participate in the Contest. Public libraries generally offer internet access free of charge. No other type of entry (including via postal mail) will be accepted.

5 ENTRY LIMITS AND CONDITIONS

5.1 Limit of one Contest entry per person, mailing address, email address, and IP address. Using more than one email address or participating on behalf of another person is strictly forbidden.

5.2 For an entry to be considered valid, all fields on the form that are not marked as optional must be filled out. The information and contact information provided by the participant (including their first and last name, email address, complete mailing address, and telephone number) must be valid and accurate; failing which, the entry will be deemed ineligible, and the participant will be disqualified. Incomplete or inaccurate registrations will not be considered and will disqualify the participant.

5.3 At the Organizer’s request, participants must be able to prove their identity and confirm the personal information provided on the form. The Organizer and Co-organizer reserve the right to verify the accuracy of information supplied by participants at the time of entry.

5.4 If it is discovered by the Organizer (using any evidence or other information made available to or otherwise discovered by the Organizer) that any person has attempted to: (i) exceed any of the limits stated in these Rules; (ii) use multiple names, identities, e-mail addresses, and/or use any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or to disrupt the Contest; and/or (iii) disrupt or participate in the Contest in any other fraudulent or misleading way, then they may be disqualified from the Contest in the sole and absolute discretion of the Organizer. The Contest Parties and each of their respective agents, employees, representatives, directors, officers, successors, and assigns (collectively, the “**Released**

Parties") are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed, incomplete or incompatible entries and/or any other Contest-related information, all of which are void. An entry may be rejected if, in the sole and absolute discretion of the Organizer, the Entry is not submitted and received in accordance with these Rules during the Contest Period (as determined by the Organizer in its sole and absolute discretion).

BY PARTICIPATING IN THIS CONTEST, YOU AGREE TO RELEASE THE RELEASED PARTIES FROM ANY AND ALL LIABILITY IN CONNECTION WITH THE CONTEST AND YOUR PARTICIPATION THEREIN AND TO INDEMNIFY THE RELEASED PARTIES AGAINST ANY AND ALL CLAIMS, DAMAGES, LIABILITIES, COSTS, AND EXPENSES ARISING FROM YOUR PARTICIPATION IN THE CONTEST. BY PARTICIPATING IN THIS CONTEST, YOU ALSO AGREE THAT YOUR ENTRY (AND EACH INDIVIDUAL COMPONENT THEREOF) COMPLIES WITH ALL CONDITIONS STATED IN THESE RULES. 6 PRIZE

6.1 One (1) prize is available in the Contest (the "**Prize**"), consisting of:

- **Two 5-Attraction Passport MTL** passes to explore the city's must-see sights (approximate retail value of \$198)
- **\$400 TREATER gift card** redeemable at any of their 60+ partner restaurants in Montréal (value of \$400)
- **Montréal's "Beyond the Market" food tour** for two offered by Spade & Palacio (approximate retail value of \$150)
- **Cirka Distillery Tour and Tasting** (approximate retail value of \$150)
- **\$100 Marchés publics de Montréal gift card** (value of \$100)
- **Two 3-day, All modes A city transit passes from Société de Transport de Montréal (STM)** (approximate retail value of \$44)

6.2 The total approximate retail value of the Prize is \$5,097 based on a flight departing from •. Travel must be completed by October 31, 2026. Certain conditions and blackout periods apply. Air Canada blackout periods until October 2026 include: 15 December 2025 to 05 January 2026; 01 April 2026 to 08 April 2026; 26 July 2026 to 16 August 2026. Tourisme Montreal activities Blackout Period: based on inventory availability at time of travel. Blackout dates: December 20, 2025 to January 4, 2026; May 20-27, 2026; July 26 - August 5, 2026; and September 18-29, 2026.



The Contest Parties accept no liability in the event of non-boarding due to force majeure. Expenses incurred as a result of non-boarding, such as hotels, restaurants, cabs, telephones and lost working days, are to be borne by the passenger and cannot be claimed. In the event of non-boarding due to force majeure, the Organizer and the co-organizers shall have no obligation to provide a replacement prize or to pay any other compensation whatsoever to the traveler due to such non-boarding or to the impossibility of fully benefiting from the prize.

restrictions may apply; (xvii) the Released Parties will not be in any way responsible (and for greater certainty, are not obligated to offer any substitute prize) in the event that any part of the Prize is delayed, postponed, rescheduled or cancelled for any reason whatsoever (including, without limitation, due to illness or health risks, or any governmental or health authority orders, measures, directives or guidance in response to such illness or risks, such as, without limitation, those that may be implemented to mitigate COVID-19 transmission, or due to any other cause of any kind or nature whatsoever); (xviii) gift cards and tickets are subject to all applicable terms and conditions as stated by the issuer, and the winner and their guest must abide by all venue policies and event ticket terms and; (xx) by participating in the Prize, the winner and their guest each: (a) signifies that they understand, acknowledge and accept that participation in the Prize may involve danger and/or exposure to risks and hazards (including without limitation as may be due to the inherent risks of travel), whether arising from foreseeable or unforeseeable human error and negligence, and that, as a result, they may suffer damage to personal property, serious personal injury, illness or even death; (b) signifies that they acknowledge and agree that the Released Parties have not made any warranties, guarantees or representations about his/her safety while participating in the Prize; and (c) warrant and represent that they have evaluated the nature, scope, and extent of the risks involved, and freely and voluntarily agree and assume any and all such risks arising out of or connected with their participation in the Prize; and (xxi) the confirmed winner and their guest travel at their own risk and, if for any reason any aspect of the Contest or Prize is not capable of running as planned, the Organizer and/or Prize Provider reserves the right to cancel, terminate, modify or suspend the Contest or suspend, substitute or modify the Prize.

7 SELECTION OF THE ELIGIBLE WINNER BY RANDOM DRAW

7.1 The eligible winner will be selected after the end of the contest by random draw from all eligible entries received in accordance with these Rules during the Contest Period. 7.3 The odds of winning will vary depending on the number of eligible entries received during the Contest Period.

8 ELIGIBLE WINNER NOTIFICATION AND CONFIRMATION PROCESS

8.1 The participant selected as the eligible winner will be notified by the Organizer by email and/or telephone, using the information provided in their entry, by •. The eligible winner must reply to the email or call the Organizer at the number indicated in the email or phone call within five (5) days of receiving said email or phone call, failing which the participant will be deemed to have forfeited their prize and an alternate potential winner may be selected in accordance with the procedures outlined above at the Organizer's sole and absolute discretion (in which case the foregoing provisions of this section shall apply to such new potential Prize winner).

8.2 NO ONE IS THE WINNER UNLESS AND UNTIL THE ORGANIZER OFFICIALLY CONFIRMS THEM AS THE WINNER IN ACCORDANCE WITH THESE RULES. In order to be declared the winner, the potential winner must first correctly answer, unaided, a time-limited mathematical skill testing question administered by the Organizer (which may, at the Organizer's sole and absolute discretion, be administered via the Organizer's declaration and release form described in the following sentence). 9.2 By entering or attempting to enter this Contest, the participant releases and holds harmless the Released Parties with respect to the malfunctioning of any computer component, software, or line of communication; the loss or absence of network communication; or any transmission that is faulty, incomplete, incomprehensible, or deleted by any computer or network and that may limit or prevent participation in the Contest, including cases of computer piracy. The participant also releases the Released Parties from any liability for any damage or loss that may be caused by a technological malfunction that impedes the draw from proceeding as planned or may otherwise affect the proper operation of the Contest. The participant also releases the Released Parties from any liability for any damage or loss that may be caused, directly or indirectly, in whole or in part, by the downloading of any internet page or software or the transmission of any information related to participation in the Contest. Without limiting the generality of the foregoing, the Released Parties do not guarantee in any way that the Devourfest.com website, or any other website related to the Contest, if applicable, will be accessible or functional without interruption during the Contest or free of errors, including errors that allow third parties to access personal data transmitted by participants using the entry form.

9.3 By entering or attempting to enter this Contest, the participant releases the Released Parties from any liability for any damages they may experience and forever waives any claims for compensation against the Released Parties or actions or causes of action of any kind whatsoever against the Released Parties in connection with (i)

their participation or attempted participation in the Contest; (ii) any service interruption or malfunction that would delay or prevent the delivery of the prize once it has been dispatched by the Organizer, Prize Provider or a prize supplier; (iii) the acceptance or use of the Prize or any component thereof, including with respect to its condition and quality; and (iv) any delay in the transmission of any emails that do not originate from their own servers.

10 PROTECTION OF PERSONAL DATA

10.1 Devour! The Food Film Festival collects the personal data of participants to organize the contest. The processing is based on the consent of the data subject. It is carried out in accordance with the provisions of the following laws: Canadian law regarding the protection of personal data : PIPEDA (Personal Information Protection and Electronic Documents Act).

10.2 By participating in this contest, participants consent to the collection and use of their personal data. This personal data will be collected, used, and disclosed by the Organizer, as well as its agents, representatives, and service providers, and other parties that it may designate for the purpose of administering the Contest in accordance with these Rules and the Organizer's privacy and confidentiality policy, available at <https://devourfest.com/privacy-policy/>.

11 USE OF IMAGES except where prohibited by law, by entering the contest, participants consent to the use of their name, image, statements, voice, and/or city and province of residence by the organizer and its representatives anywhere in the world, for any purpose whatsoever and via any form of media, without additional Compensation.

12 CHANGES TO THE CONTEST AND THE ORGANIZER'S DECISIONS

12.1 The Organizer reserves the right to suspend, cancel or modify the Contest at any time if it determines, for any reason, that the Contest cannot be conducted as originally planned, or for any other event or reason that compromises the fairness or integrity of the Contest. This includes situations where a prize or a portion thereof is no longer available due to force majeure. For the purposes hereof, "force majeure" means any unforeseeable and irresistible event beyond the control of the Organizer or one or more suppliers of the goods and services comprising the prize or any part thereof, including, but not limited to, the following: war (whether declared or not), rebellion, insurrection, intervention by military or civilian armed forces, act of government or order of court or public authority, restrictions on international flights, legislative or regulatory change, riot, act of terrorism, strike, spontaneous work stoppage or slowdown, failure of telecommunication or power lines, epidemic, pandemic, or natural phenomenon.

12.2 All the Organizer's decisions regarding any matter related to the Contest are final in all respects, and the persons eligible to participate in the Contest agree to comply with all the Organizer's instructions and decisions. In the event that a dispute arises regarding the interpretation of any provision of these Rules, the Organizer's decision or interpretation shall be final and binding on all Contest participants.

12.3 Conditions that are specific to the Prize are subject to change without notice.

13 DISPUTES

13.1 Except where prohibited by law, participants consent to the following: (i) except or participants residing in the province of Quebec any dispute, claim, or cause of action arising out of or related to the Contest or any prize awarded in connection with the Contest shall be resolved without resorting to any form of class action.; (ii) any claim, judgment, or damages awarded to any individual shall be limited to the expenses actually incurred, including the costs associated with participation in the Contest, but shall in no event include any legal fees; and (iii) in no event shall indirect, punitive, or incidental damages, or any damages other than reimbursable expenses, be claimed or awarded, and any right to multiply or increase any such damages, if applicable, shall be waived.

14 INTELLECTUAL PROPERTY

All intellectual property, promotional material, websites, and source codes are the property of the Organizer and related entities. All rights reserved. Unauthorized use or copying of any copyrighted or trademarked material without the express written consent of its owner is strictly prohibited.

15 GENERAL PROVISIONS

15.1 To the extent permitted by applicable law, and except with regards to consumers residing in the province of Quebec, the Contest will be governed, as applicable, by the laws of the province of Nova Scotia. and by Canadian law, excluding conflict of law rules that could lead to the application of laws from other jurisdictions.

15.2 The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.

15.3 In the event of any discrepancy or inconsistency between the terms and conditions of these English Rules and disclosures or other statements contained in any Contest related materials, including but not limited to the French version of these Rules, website, or point of sale, television, print or online advertising, the terms and conditions of these English Rules shall prevail, govern and control.
